Snapshot

Tracxn Insights (1/5)

- Southeast Asia's FinTech startup ecosystem is home to more than 8.5K companies, out of which more than 2.1K companies are funded to date. The region witnessed its peak funding in Q3 2021, after which the funding started to decline steadily except for Q2 2022
 - The decline in Southeast Asia's FinTech sector stems from a tougher global funding climate, increased investor focus on profitability, and growing market saturation across key verticals
 - Additional factors include regulatory tightening, macroeconomic uncertainty, and reduced consumer demand
 - Despite the decline in funding in this space, the region is witnessing a significant increase in digital adoption along with government support and the growing focus of FinTech companies in this region with region-specific solutions

Tracxn Insights (2/5)

- In Q1 2025, the SEA FinTech startup ecosystem has witnessed a total of \$193M in funding, a 66% and 30% drop as compared to the funding raised in Q1 2024 and Q4 2024 which saw \$584M and \$274M in total funding, respectively
 - Seed-stage rounds in Q1 2025 witnessed \$34.1M in total funding, a decline of 52% and 22% compared to \$70.7M and \$43.6M raised in Q1 2024 and Q4 2024, respectively
 - Early-stage rounds in Q1 2025 saw a funding of \$101M, a 68% drop compared to the \$318M funding raised in Q1 2024, while an increase of 47% compared to the \$68.8M raised in Q4 2024
 - Late-stage rounds witnessed a total funding of \$58M in Q1 2025, experiencing a drop of 70% and 64% compared to the \$195M and \$162M raised in Q1 2024 and Q4 2024 respectively
 - January was the highest funded Month in Q1 2025 with \$108M raised, accounting for 57% of the total funding this quarter

Tracxn Insights (3/5)

- Cryptocurrencies, Alternative Lending, and Investment tech were the top performing segments in the SEA Fintech ecosystem in Q1 2025
- Cryptocurrencies segment witnessed a funding of \$97.5M in Q1 2025, a drop of 24% compared to \$129M received in Q1 2024 and a 3% decline in comparison with \$101M raised in Q4 2024
 - Sygnum, provider of banking solutions for digital assets, raised \$58M in a Series C funding round
- Alternative Lending segment has witnessed a total funding of \$34.6M in Q1 2025, a decline of 47% compared to \$65.4M in Q1 2024 and a drop of 40% compared to \$57.5M raised in Q4 2024
 - Techcoop, a Fintech platform providing lending solutions to the agriculture industry, raised \$28M in Series A funding round
- Investment tech segment saw a total funding of \$34.3M in 2024, a drop of 45% and a growth of 37% compared to \$62.7M and \$25M raised in Q1 2024 and Q4 2024, respectively

Tracxn Insights (4/5)

- Endowus, provider of goal-based investment platform for individuals, raised \$17.5M in Series B funding round
- The SEA Fintech space has not witnessed any \$100M+ funding rounds in Q1 2025. In contrast, there was one \$100M+ funding round in Q1 2024 and Q4 2024 each
- The SEA Fintech space witnessed one Unicorn in Q1 2025, while 1 Unicorn was observed in Q1 2024. No Unicorns were seen in Q4 2024 in this space
 - Sygnum, provider of banking solutions for digital assets, earned the Unicorn status in January 2025, and it is the only FinTech company to become a Unicorn in 2025 on a global scale
- The SEA FinTech space did not witness any IPOs in the last 5 quarters
- The SEA FinTech sector recorded 6 acquisitions in Q1 2025, reflecting a 45% decline from 11 acquisitions in Q1 2024 but a 20% increase compared to 5 in Q4 2024

Tracxn Insights (5/5)

- Coinseeker, a blockchain intelligence platform, was acquired by Titanlab, a development arm of Tokenize Xchange in a deal valued at \$30M
- Singapore leads the funding in SEA Fintech space as the highest funded city, followed by Thu Duc and Petaling Jaya
 - 74% of the funds raised in SEA Fintech space is from Singapore
- East Ventures, Y Combinator, and 500 Global are the overall top investors in the SEA Fintech startup space
 - Iterative, Selini Capital and AppWorks are the top Seed-stage investors in Q1 2025
 - Citi Ventures, HSG and PayPal Ventures are the top Early-stage investors in Q1 2025







Q-o-Q # of unique Institutional Investors in SEA Fintech










Cities by Total Funding
